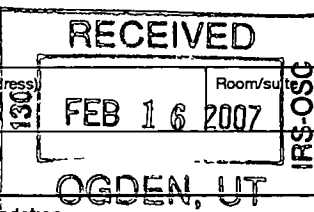

On September 30, 2005, the Sam Mazza Foundation filed its articles of incorporation with the state of California. The foundation subsequently received its determination of exempt status from the Internal Revenue Service. However, the foundation was inactive up to February, 2006, when it received its first contribution funding. The foundation had intended to use a calendar year-end for private foundation return filing purposes. However, the foundation had inadvertently failed to file its initial December 31, 2005 returns prior to the May 15, 2006 filing deadline, since it was functionally inactive during all of 2005. Accordingly, the taxpayer is filing its initial December 31, 2005 private foundation returns at this time.
